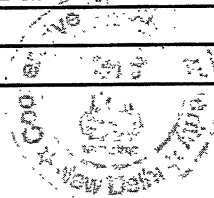

For conduct of elections of Office Bearers, it is requested that Rule 19N i.e. "Election of office bearers by secret ballot" be kept in view which inter-alia provide that the meeting to elect office bearers shall not be conducted unless majority of newly elected members of the board are present. Further such meeting shall be presided over by Returning Officer.

4. Returning Officer is requested to refer to Section 44 of the Multi State Cooperative Societies Act, 2002 to ensure that member of the Board of Director recommended for the position of Chairperson or President has not been the Office of Chairperson or President during two consecutive terms; whether full or part. RO is requested to obtain the information from Directors filing nomination in the following format:

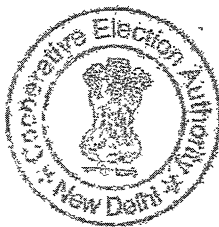
5. Returning Officer is also requested to direct CEO of Ram Agro Marketing Cooperative Society Limited, Delhi, that the result of the election of Board of Director may be displayed in conspicuous manner on the website of the society.

6. Returning Officer is also requested to ensure that society has deposited remuneration for Returning Officer/Assistant Returning Officer/Polling Officer in Cooperative Election Authority's Account.

7. **Preparation of Account and loading of the same:** From conjoint reading of the Rule 19U & Rule 19W, it is clear that all candidate shall prepare account of all expenditure in connection with the election. Account be prepared as per particulars given in Rule 19W. No limit for election expenditure for the candidate has been fixed by Cooperative Election Authority till now. The account of expenditure must be lodged with the Returning Officer within 30 days otherwise it attracts disqualification for failure to lodge account of election expenses.


