While filling nominations for Office Bearers, the following information may be obtained:

5. Returning Officer is also requested to direct CEO of Thiruvalluvar Transport Corporation Employees Cooperative Credit Society Limited, Chennai, Tamil Nadu that the result of the election of Board Members may be displayed in conspicuous manner on the website of the society.

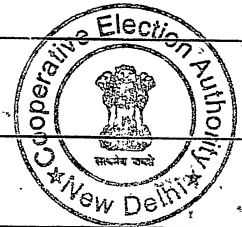

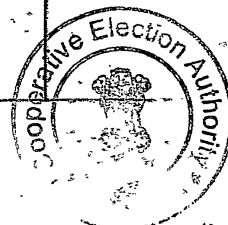
