**ORDER**

(Under section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas, Lustiness Janhit Credit Cooperative Society Ltd., 77-B, Chhatterpur Enclave, Maidan Garhi Road, New Delhi-110074 (Regn.No. MSCS/CR/756/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies Act, 2002 and Rules framed thereunder (hereinafter referred as Act).

2. Vide this Office Order of even number dated 29.04.2025, Deputy Commissioner/District Magistrate, District - South West, Government of NCT of Delhi was appointed as the liquidator of the Society under the provisions of the Act and Rules framed thereunder.

3. District Magistrate, District - South West, Government of NCT of Delhi vide letter No. PA/DM/SW/2025/91733 dated 11.12.2025 has informed that the registered address of the Society falls under the jurisdiction of District - South and requested to change the liquidator of the Society accordingly.

4. Therefore, after careful consideration of the facts, I, Rabindra Kumar Agarwal, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 89(1) of the Act, appoint Deputy Commissioner/District Magistrate District - South, Govt. of NCT of Delhi as liquidator of the Society until further orders in place of Deputy Commissioner, District-South West to take further necessary action as per the provision of MSCS Act, 2002 & Rules framed thereunder.

5. The liquidator shall also submit status report showing progress made in liquidation work of the Society on quarterly basis to this Office.
