**ORDER**

[Under sub-section (4) of Section 84 of the Multi State Cooperative Societies Act, 2002]

Whereas, an Arbitration Petition No. 75 of 2024 was filed on 15.01.2024 by Purvanchal Hathkargha Sahakari Sangh Ltd. against All India Handloom Fabrics Marketing Cooperative Society Ltd. & Ors before the Hon'ble High Court of Delhi, and in compliance with the order of the Hon'ble High Court of Delhi dated 24.04.2024, this Authority appointed Dr. T Philip Thanglianmang, IAS (Retired) as Arbitrator vide order dated 16.05.2024 to adjudicate the dispute between the parties.

2. Whereas, the Petitioner, Purvanchal Hathkargha Sahakari Sangh Ltd.) has again filed I.A. No. 26320/2025 in Arb. P. No.-75 of 2024 before the Hon'ble High Court of Delhi, seeking directions to the Central Registrar of Cooperative Societies (CRCS) to appoint another arbitrator, on the ground that the said arbitrator has not commenced the Arbitration proceedings in the matter. Accordingly, the Hon'ble High Court of Delhi vide order dated 19.01.2026, directed that "*the Respondent No. 2 (CRCS) shall appoint another arbitrator within a period of two weeks, in terms of the Rules governing the parties*".

3. In compliance with the order of the Hon'ble High Court of Delhi dated 19.01.2026 and in exercise of the powers conferred under sub-section (4) of Section 84 of the Multi-State Cooperative Societies Act, 2002, I, Anand Kumar Jha, Central Registrar of Cooperative Societies, hereby appoint Shri Kalayan Sahai Meena, IAS (Retd.) in place of Dr. T Philip Thanglianmang, IAS (Retired) as Arbitrator with immediate effect to adjudicate the dispute between the concerned parties.

4. The arbitration fee shall be fixed in accordance with the provisions of the Arbitration and Conciliation Act, 1996, and the arbitration proceedings shall be concluded within the time limits prescribed under the said Act.
