**ORDER**

Whereas, Dadra Nagar Haveli Sahakari Khand Udyog Mandali, New Marketing Centre, Room No. 16 & 17, Dadra Nagar Haveli, Silvassa (Regn No.: MSCS Act/CR-8/89) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. Vide Order dated 19.06.2025, Shri Amit Kumar, DANICS-Resident Deputy Collector (Silvassa), U.T. of Dadra and Nagar Haveli and Daman & Diu, was appointed as Liquidator of the Society under the provision of Section 89(1) of the Act.

3. Registrar of Cooperative Societies, Dadra & Nagar Haveli, Department of Cooperation vide letter No. COOP/SUGARMILL DNH/2024/52 dated 23.07.2025 has stated that Shri Amit Kumar, DANICS, Deputy Collector (Silvassa) will be engaged in election-related procedures and duties and proposed that Shri Sanjam Singh, DANICS, Chief Officer, Daman Municipal Council, Daman be appointed as the liquidator of the above society in place of Shri Kumar to ensure the uninterrupted continuation of the liquidation proceedings.

4. Now, therefore, after careful consideration of the facts, I, Anand Kumar Jha, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 89(1) of the Act, appoint Shri Sanjam Singh, DANICS, Chief Officer, Daman Municipal Council, Daman as a Liquidator of the Society in place of Shri Amit Kumar until further orders to take further necessary action as per the provisions of Multi-State Cooperative Societies Act, 2002 and Rules framed thereunder.

5. The liquidator shall also submit the status report showing the progress made in liquidation of the Society on quarterly basis to this Office.
