**TO WHOM SO EVER IT MAY CONCERN**

Whereas, Chatrapati Multi State Cooperative Credit Society Ltd., C/o Santosh Baswant Bhandari, Naik Nagar, Georai, Distt. Beed-431127, Maharashtra (Regn No.: MSCS/CR/712/2012) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. Commissioner for Cooperation and Registrar of Cooperative Societies, Government of Maharashtra vide letter dated 26.08.2025 has informed that Special Auditor Class-2, Cooperative Societies, Beed has conducted inspection of the Society and reported that FIR No. 0379/25 dated 18.06.2025 has been registered against the Society in Gevrai Police Station, Beed. Records have been seized and head office of the Society was sealed by the Police Authority due to which inspection could not be completed and recommended for liquidation of the Society u/s 86 of the MSCS Act, 2002.

3. A Show Cause Notice dated 03.11.2025 was issued to the Society for furnishing comments on the Inspection Report dated 26.08.2025, received from Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra. However, the Society has not furnished reply to this Show Cause Notice, signed by the duly authorised persons.

4. Further, as per the records on the CRCS Office Portal, the Society has not submitted its mandatory annual returns for the Financial Years 2023-24 and 2024-25 u/s 120 of the MSCS Act, 2002.

5. Therefore, after careful consideration of the facts, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules made thereunder. In case of any objection, the same may be brought to the Notice of this Authority within 15 days from the date of uploading of this Notice on the office website i.e., crcs.gov.in failing which it will be presumed that the Society has nothing to say and action would be initiated for winding up of the Society under the provisions of MSCS Act, 2002 and rules made thereunder.
