Further such meeting shall be presided over by Returning Officer.

4. Returning Officer is requested to refer to Section 44 of the Multi State Cooperative Societies Act, 2002 to ensure that member of the Board of Directors recommended for the position of Chairperson or President has not been the Office of Chairperson or President during two consecutive terms, whether full or part.

5. Returning Officer is also requested to direct CEO of Dadasaheb Phalke Cinema & Entertainment Multi State Cooperative Society Limited, that the result of the election of Board of Directors may be displayed in conspicuous manner on the website of the society.

6. Returning Officer is required to preside over the meeting for the purpose of elections to the office bearer by secret ballot, as per Rule 19 (2) of the MSCS Rules.

7. Returning Officer is also requested to ensure that society has deposited remuneration for Returning Officer/Assistant Returning Officer/Polling Officer in Cooperative Election Authority's Account.

8. Preparation of Account and loading of the same: From conjoint reading of the Rule 19U & Rule 19W, it is clear that all candidate shall prepare account of all expenditure in connection with the election. Account be prepared as per particulars given in Rule 19W. No limit for election expenditure for the candidate has been fixed by Cooperative Election Authority till now. The account of expenditure must be lodged with the Returning Officer within 30 days otherwise it attracts disqualification for failure to lodge account of election expenses.


