Sub: Election of Board of Director of Sahakar Taxi Cooperative Limited, New Delhi -Reg.

Sir,

In continuation of Cooperative Election Authority's letter of even number dated 10.10.2025, the undersigned is directed to convey that the matter relating to election/nomination of Shri SS Yadav representing KRIBHCO was considered by the Authority, taking into account RO's report dated 21.10.2025 and various provisions of MSCS Act and Rules framed thereunder. The report of the RO inter-alia stated that

“In this regard, Sh. M.R. Sharma, Managing Director (KRIBHCO) vide letter dated 16.09.2025 informed that Election of Board of Directors of KRIBHCO is under approval of Cooperative Election Authority and since the KRIBHCO is duty bound to nominate its representative for the Election of Board of Directors and Office bearers of Sahakar Taxi Cooperative Ltd. to represent KRIBHCO; therefore, the nomination of Sh. Sunder Singh Yadav, Director (HR) was communicated to NCDC on 29.07.2025.

Accordingly, the nomination Sh. Sunder Singh/S.S. Yadav was allowed as his nomination was authorized by the MD of the KRIBHCO and the Board of KRIBHCO was not constituted and awaiting approval of CEA as on date of filing of nomination.

In view of above position, CEA may consider to allow result of Sh. Sunder Singh / S.S. Yadav.”

2. The above report of the RO is in conflict with the Section 38(3) of MSCS Act as Shri Yadav at the time of filing of nomination i.e. till 15.09.2025 was not Managing Director in KRIBHCO and he had taken up charge as MD on 24.09.2025.

3. Section 38 (3) of the MSCS Act, which is reproduced below:

“(3) Where in any meeting of the general body or the board of a multi-state cooperative society, a cooperative society or another multi-state cooperative society is to be represented, such cooperative society or other multi-state cooperative society shall be represented in such meeting only through the



Chairperson or the president or the Chief Executive or a member of the board of such cooperative society or other multi-state cooperative society, as the case may be, if such member is so authorised by the board and where there is no board of such cooperative society or other multi-state cooperative society, for whatever reasons, through the administrator, by whatever name called, of such cooperative society or other multi-state cooperative society:”

Provided that where the bye-laws of a multi-state cooperative society provide for representation of other institutions in any meeting of general body or the board of such multi-state cooperative society, such institutions shall be represented through its nominee.

4. In the instant case Shri Yadav was not occupying the position of Chairperson or the president or the Chief Executive or a member of the board of KRIBHCO till the last date of filing of nomination i.e. 15.09.2025.
5. Accordingly, Authority has decided that the order dated 10.10.2025 withholding the election of Shri Yadav on the Board of Director, be modified and election of Shri Yadav be declared void ab-initio as Shri Yadav was not fulfilling the condition to file the nomination.
6. This issue with the approval of Cooperative Election Authority.
