3. Returning Officer is also requested to direct CEO of Ram Agro Marketing Cooperative Society Limited, Delhi that the result of the election of Office Bearers may be displayed in conspicuous manner on the website of the society.

4. Returning Officer is also requested to ensure that society has deposited remuneration for Returning Officer/Assistant Returning Officer/Polling Officer in Cooperative Election Authority's Account.



5. **Preparation of Account of election expenses and lodging of the same with RO:** From conjoint reading of the Rule 19 U & Rule 19 W, it is clear that all candidates shall prepare account of all expenditure in connection with the election. Account be prepared as per particulars given in Rule 19 W. No limit for election expenditure for the candidate has been fixed by Cooperative Election Authority till now. The account of expenditure must be lodged by the candidates with the Returning Officer within 30 days otherwise it attracts disqualification for failure to lodge account of election expenses. Such compiled return may be submitted to the Authority.

6. As per para 9 Handbook of Returning Officer - Instructions for filling up Format 19N for the Returning Officer to seek prior approval of result of election of Office Bearers which states that:

“ The Returning Officer shall prepare proceedings of the elections of the Office Bearers and submit a copy of proceedings immediately after the meeting on the same day. A copy of such report together with a copy of the Return [Rule 19M(14)] of the polling, to the Authority (Rule 19 N (5) of MSCS Act and Rules.”

In this case poll for Office Bearers was held on 28.08.2025, the result of which was to be reported to Cooperative Election Authority immediately. However, it has been reported to Cooperative Election Authority on 01.04.2026 after a lapse of 7 Months. Therefore, it is requested to explain the reasons for delay in sending the result to Cooperative Election Authority for approval within 7 days.
