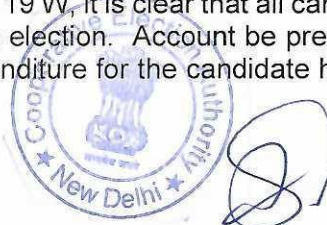

Such compiled return may be submitted to the Cooperative Election Authority (CEA).
