ORDER


{Under sub – section (4) of Section 84 of the MSCS Act, 2002}

Sh. K.S. Meena, IAS (Retd.), Sole Arbitrator, vide his letter dated 05.02.2026 has stated that the arbitration proceedings in the matter of Shri Ramdas P. Sandhe & Ors. Vs. FISHCOPFED & Ors. are ongoing and presently at the stage of recording of evidence. It has been submitted that the proceedings could not be concluded within the stipulated time due to impleadment of additional parties, increase in number of respondents, and filing of various interim applications under the Arbitration and Conciliation Act, 1996. Further, it has been informed that a total of twenty-four (24) issues have been framed for adjudication and the matter requires additional time for completion. Accordingly, the Arbitrator has requested for extension of time by a further period of five (5) months to conclude the arbitration proceedings.

2. Due to the reasons stated above, it has been deemed expedient to extend the time for completion of arbitration proceedings. Therefore, in continuation of this office order of even number dated 05.03.2024, the time period for completion of arbitration proceedings is hereby extended up to 10.07.2026. The Arbitrator is requested to complete the arbitration proceedings within the extended period.
