**Public Notice**

**Non-Filing of Annual Returns under MSCS Act, 2002  
(Amended in 2023)**

WHEREAS, Section 120 of the MSCS Act, 2002, requires all MSCS societies to file annual returns on the CRCS portal within six months of the closure of the accounting year, i.e. by September 30th annually.

The following Credit & Thrift Societies headquartered in Delhi (7), Haryana (4) and Rajasthan (8) states have not filed their Annual Returns for the financial year 2024-25 within the stipulated period, thereby violating the provisions of the MSCS Act, 2002 and attracting penalties under section 104(1) and disqualification for being member of board of the society, in case of individuals, under section 43(2)(e) of MSCS Act 2002:
