Whereas, Sarvottam Agro Cooperative Society Ltd., 142, Sharda Sadan, Lane no. 28, Amit Gram Gumaniwala, Rishikesh, Dehradun, Uttarakhand 249201 (Regn. No.: MSCS/CR/1151/2014) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. A letter dated 11.06.2024 was received from Additional Registrar, Cooperative Societies, Uttarakhand informing therein that in the SLCC-Sub Committee held on 15.03.2024, it was discussed that a complaint was published in Dainik Jagran on 01.03.2023 related to non-refund of Rs. 75 lakhs collected from the public by Sarvottam Agro Cooperative Society Ltd., and the Chair directed Registrar of Cooperative Societies, Govt. of Uttarakhand to get the action taken on Sarvottam Agro Cooperative Society Ltd., by the Central Registrar of Cooperative Societies. Vide letter dated 16.07.2024, the Society was requested to furnish explanation in the matter. However, the said letter was returned undelivered with remark addressee not found.

3. Registrar of Cooperative Societies, Govt. of Uttarakhand, vide letter dated 02.08.2024, was requested to conduct an inspection u/s 108 of the MSCS Act, 2002 of the Society. An inspection report dated 12.11.2025 was received from the Registrar of Cooperative Societies, Govt. of Uttarakhand and reported that Society was not found functioning at its registered address.

4. Further, as per the records of CRCS Office Portal, the Society has not filed its mandatory annual returns u/s 120 of the MSCS Act, 2002 to this Office.

5. Therefore, after careful consideration of the facts, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules made thereunder. In case of any objection, the same may be brought to the Notice of this Authority within 15 days from the date of uploading of this Notice on the office website i.e., crcs.gov.in failing which it will be presumed that the Society has nothing to say and action would be initiated for winding up of the Society under the provisions of MSCS Act, 2002 and rules made thereunder.
