Returning Officer is requested to refer to Section 44 of the Multi State Cooperative Societies Act, 2002, to ensure that member of the Board of Director recommended for the position of Chairperson or President has not been the Office of Chairperson or President during two consecutive terms, whether full or part. While filling nominations for Office Bearers, the following information may be obtained:

6. Further such meeting shall be presided over by Returning Officer.

7. **Preparation of Account of election expenses and lodging of the same with RO:** From conjoint reading of the Rule 19 U & Rule 19 W, it is clear that all candidates shall prepare account of all expenditure in connection with the election. Account be prepared as per particulars given in Rule 19 W. No limit for election expenditure for the candidate has been fixed by Cooperative Election Authority till now. The account of expenditure must be lodged by the candidates with the Returning Officer within 30 days otherwise it attracts disqualification for failure to lodge account of election expenses. Such compiled return may be submitted to the Cooperative Election Authority (CEA).

8. Returning Officer is requested to ensure that society has deposited remuneration for Returning Officer/Assistant Returning Officer/Polling Officer in Cooperative Election Authority's Account.
