**Sub: Approval of Recommendations of Election Result of Board Members of The Jalgaon People's Co-operative Bank Limited, Jalgaon, Maharashtra and Revised Election Programme for Office Bearers.**

Sir/Ma'am,

The Cooperative Election Authority vide Order of even number, dated 23.01.2026 issued the Election programme and appointed the District Magistrate, Jalgaon as RO.

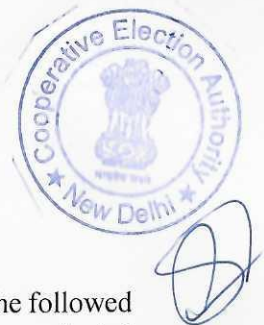
2. RO vide his letter dated 11.04.2026 forwarded his recommendations to seek prior approval of the elections of the Board of Directors of The Jalgaon Peoples Cooperative Bank Ltd., Jalgaon, Maharashtra as per Rule 19M.

3. RO recommendation dated 11.04.2026 were considered by the Authority wherein it was observed that during scrutiny process 11 nomination forms were rejected and 4 nominations were withdrawn. The election, thus, was uncontested. The Authority considered the matter & sought clarification from RO vide letter dated 30.04.2026 on the following aspects:

a) The nomination paper does not bear the date and time at which the nomination form has been received by Returning Officers or Assistant Returning Officer (ARO) as required under Rule 19J.

b) Scrutiny of nomination papers does not appear to have been done as per Rule 19L. As per Rule 19L(c), in case a nomination form is rejected, Returning Officer shall record in writing a brief statement of his reasons for such rejection. None of the nomination papers, records any reasons for rejection of the nomination papers including in case of rejection of nominations filed by Shri Chandrashekhar Devidas Attarde, on account of non-mentioning of constituency on the Nomination Paper.

3. RO vide his captioned letter as referred above dated 02.05.2026 submitted that he followed all the procedure prescribed in the guideline for RO and the reasons for rejection were communicated



to the candidates under signature of RO, who had filed Nomination Papers. These communications have been duly acknowledged by the concerned members/candidates. Not satisfied with the response, RO was requested again to reconsider his recommendations including non-preparation of constituency wise member list. Had the constituency-wise member list been prepared, then the question of rejecting Nomination of Mr. Devidas Attarde on the ground of incorrect mentioning of constituency would not have arisen. RO vide his letter dated 08.05.2026 reiterated that the entire procedure was followed in transparent and impartial manner and informed that voter list was prepared Branch wise. RO has stated that he specifically asked Shri Chandrashekar Devidas Attarde to clarify the constituency from which he desired to contest the election, but he was unable to provide a clear and satisfactory response in this regard. After rejecting nomination form. Shri Attarde had not raised any objection to the said rejection till date.

4. The Authority has considered the response of RO in totality and accordingly, decided to approve the Form 19M in its meeting held on 14.05.2026 but with the directions/request to the RO that scrutiny of Nomination is a sacrosanct process and it is essential to ensure integrity of all the processes and it should have been followed in letter and spirit including:

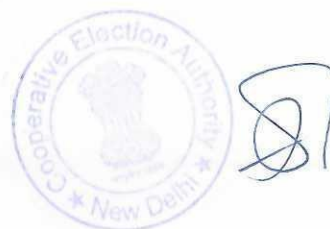
a) Ensure that while accepting Nomination Form, RO shall **enter on the Nomination Form, its serial number and certify the date and time at which Nomination Form** has been received by him (Rule 19J(3)).

b) Returning Officer shall endorse on each Nomination Form his decision of accepting or rejecting the same, as the case may be, and if Nomination Paper is rejected, **he shall record in writing in brief Statement of his reasons on such rejection (Rule 19L.(1)(c)).**

5. However, Authority has accepted the recommendation sent by you vide letter dated 11.04.2026 and reiterated vide letters dated 02.05.2026 and 08.05.2026 with the rider that RO shall keep in mind the clear provision in the Rules relating to Scrutiny as also summarized in Para 4 above. Now, you are requested to declare the results. Name and address of the Board of Members have been indicated by RO in Format 19 M (Under Rule 19 M) as per details below: -

6. Returning Officer is also requested to direct CEO of The Jalgaon People's Co-operative Bank Limited, Jalgaon, Maharashtra that the result of the election of Board Members may be displayed in conspicuous manner on the website of the society.

8. For conduct of election of Office Bearers, it is requested that Rule 19 N i.e. "Election of Office Bearers by secret ballot" be kept in view of which inter-alia provide that the meeting to elect office bearers shall not be conducted unless majority of newly elected members of the board are present

9. Returning Officer is requested to refer to Section 44 of the Multi State Cooperative Societies Act, 2002, to ensure that member of the Board of Director recommended for the position of Chairperson or President has not been the Office of Chairperson or President during two consecutive terms, whether full or part. While filling nominations for Office Bearers, the following information may be obtained:

10. Further such meeting shall be presided over by Returning Officer.

11. **Preparation of Account of election expenses and lodging of the same with RO:** From conjoint reading of the Rule 19 U & Rule 19 W, it is clear that all candidates shall prepare account of all expenditure in connection with the election. Account be prepared as per particulars given in Rule 19 W. No limit for election expenditure for the candidate has been fixed by Cooperative Election Authority till now. The account of expenditure must be lodged by the candidates with the Returning Officer within 30 days otherwise it attracts disqualification for failure to lodge account of election expenses. Such compiled return may be submitted to the Cooperative Election Authority (CEA).

12. Returning Officer is requested to ensure that society has deposited remuneration for Returning Officer/Assistant Returning Officer/Polling Officer in Cooperative Election Authority's Account.
