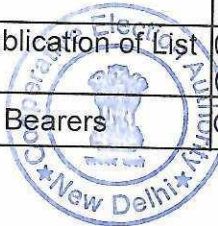



Hence, This is a revised form No.19 M for an approval.



Section – B (for office of Cooperative Election Authority only)

Returning Officer on 01.04.2026 submitted Form 19M recommending approval for election of 17 Directors. CEA on examination found that there is some inconsistency in the eligibility of recommended Directors and Requested RO on 09.04.2026 to revisit his recommendations. After revisiting, RO found that 6 Candidates which were recommended elected earlier are ineligible. RO vide his letter dated 20.05.2026 made fresh recommendations for election of 11 Directors in Form 19M.

CEA has accepted and approved RO's recommendations of dated 20.05.2026 recommending 11 Directors elected in the Board, as given in Section A above.
