ORDER

(Under section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas, **Janshakti Multi-State Multi-Purpose Cooperative Society Ltd., Rathi Building, Plot No. 231/18A, Veena Enclave, Nangloi, New Delhi-110041** (Regn. No.: MSCS/CR/562/2012) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies Act, 2002 and Rules framed thereunder (hereinafter referred as Act).

2. Vide this Office Order of even number dated 30.05.2025, Deputy Commissioner/District Magistrate, District - West, Government of NCT of Delhi was appointed as the liquidator of the Society under the provisions of the Act and rules made thereunder.

3. District Magistrate, District - West, Government of NCT of Delhi vide letter No. PA/DCW/MSCS-2002/SKYLARK/2026/5997 dated 24.04.2026 has informed that after the Notification No. F.223/SDM-II(HQ)/land/2025-285 dated 25.12.2025 for reorganization of Districts and their boundaries, the area of Nangloi falls under the territorial jurisdiction of District Outer North and requested to appoint the District Magistrate, Outer North as the liquidator of the Society in his place.

4. Therefore, after careful consideration of the facts, I, Anand Kumar Jha, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 89(1) of the Act, appoint Deputy Commissioner/District Magistrate District – Outer North, Govt. of NCT of Delhi as liquidator of the Society until further orders in place of Deputy Commissioner, District- West to take further necessary action as per the provision of Act & Rules framed thereunder.

5. The liquidator shall also submit status report showing progress made in liquidation work of the Society on quarterly basis to this Office.
