TO WHOM SO EVER IT MAY CONCERN

Whereas, Swapnavedh Multi State Cooperative Credit Society Ltd., C-2, Galories Park, Plot No.67, Sect. No.03, Indrayani Nagar, Bhosari, Pune-411039, Maharashtra (Regn. No.: MSCS/CR/740/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules framed thereunder (hereinafter referred as Act).

2. Whereas, as per the periodic report submitted by Office of Cooperative Ombudsman, it was observed that Orders dated 11.03.2025 and 10.09.2025 was issued by Cooperative Ombudsman with the direction to the Society to pay the amount due & claimed by the complainant against his deposit. However, neither society complied with the order nor it filed an appeal before the Central Registrar of Cooperative Societies.

3. Hearings of the Society (through Video Conference) before this Authority were held on 16.10.2025, 27.11.2025, and 24.02.2026, however, no authorized representative of the Society appeared on any of the aforesaid dates, thereby demonstrating continued non-cooperation towards official communications given by this Office.

4. As per the records of CRCS portal, Society has not submitted its mandatory annual returns u/s 120 of the MSCS Act, 2002 to this Office thereby violating provision of MSCS Act, 2002 and Rules framed thereunder.

5. Therefore, after careful consideration of the facts, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules framed thereunder. In case of any objection, the same may be brought to the notice of this authority within 15 days from the date of uploading of this Notice on the official website i.e., crcs.gov.in failing which it will be presumed that the Society has nothing to say and further action would be initiated for winding up of the Society under the provisions of the MSCS Act, 2002 and rules made thereunder.
