TO WHOM SO EVER IT MAY CONCERN

Whereas, KSB Multistate Cooperative Credit Society Ltd., Flat No.603, GH-104-G, Sector-20, Panchkula, Haryana-134116 (Regn. No.: MSCS/CR/791/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules framed thereunder (hereinafter referred as Act).

2. Inspection report dated 28.11.2025 was received from Assistant Registrar, Cooperative Societies, Panchkula, O/o Registrar of Cooperative Societies, Govt. of Haryana reporting therein that vide letter dated 16.09.2025, Chairman/Secretary of the Society was directed to appear along with records of the Society. But nobody appeared before him. Further, Inspector, Cooperative Societies, Panchkula-I has conducted a physical inspection of the Society at its registered address, however, the society was not found functioning at its registered address.

3. Further, as per the records of CRCS Office portal, the Society has not submitted its mandatory annual returns for the financial year 2024-25 u/s 120 of the MSCS Act, 2002 to this Office thereby violating provision of MSCS Act, 2002 and Rules framed thereunder.

4. It appears that the Society is not functioning at its registered address thereby violating the provision of MSCS Act, 2002, Rules framed thereunder and Co-operative Principles.

5. Therefore, after careful consideration of the facts, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules framed thereunder. In case of any objection, the same may be brought to the notice of this authority within 15 days from the date of uploading of this Notice on the official website i.e., crcs.gov.in failing which it will be presumed that the Society has nothing to say and further action would be initiated for winding up of the Society under the provisions of the MSCS Act, 2002 and rules made thereunder.
