

TO WHOM IT MAY CONCERNED

Whereas, Unique Swayam Multi State Multi Purpose Cooperative Society Ltd., 3rd Floor, Unique House, behind ICICI Bank, Opp. Union Bank of India, Ashram Road, Ahmedabad-380009, Gujarat (Regn. No.: MSCS/CR/900/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules framed thereunder (hereinafter referred as Act).

2. Several complaints were received in this Office against Unique Swayam Multi State Multi Purpose Cooperative Society Ltd. regarding non-repayment of depositor's money by the Society.
3. Registrar of Cooperative Societies, Government of Gujarat vide letter dated 22.12.2025 and reminder dated 16.03.2026 was requested to conduct the inspection of the Society u/s 108 of the MSCS Act, 2002, and to submit the report to this Office.
4. Further, the Society has not filed its mandatory annual returns u/s 120 of MSCS Act, 2002 to the Central Registrar from the financial years 2021-22 onward.
5. Cooperative Ombudsman vide orders dated 21.01.2025, 17.07.2025, and 22.10.2025 directed the Society to refund the deposits to the depositors/members of the Society within stipulated time period. However, despite repeated opportunities and clear directions issued by the competent authority, the Society has failed to comply with the aforesaid Ombudsman Orders and has not submitted any satisfactory explanation or compliance report before this office.
6. Hearings through Video Conference before the Central Registrar were held on 16.10.2025, 27.11.2025, and 24.02.2026; however, no authorized representative of the Society appeared in these hearings.

7. Therefore, after careful consideration of the facts, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules framed thereunder. In case of any objection, the same may be brought to the notice of this authority within 15 days from the date of uploading of this Notice on the official website i.e., crcs.gov.in failing which it will be presumed that the Society has nothing to say and further action would be initiated for winding up of the Society under the provisions of the MSCS Act, 2002 and rules made thereunder.
