
महोदय/ Sir,

मुझे बहु-राज्य सहकारी समितियाँ (संशोधन) अधिनियम, 2023 द्वारा संशोधित बहु-राज्य सहकारी समितियाँ अधिनियम, 2002 के प्रावधानों का उल्लेख करने का निर्देश दिया गया है, जो अन्य बातों के साथ-साथ यह आदेश देता है कि प्रत्येक बहु-राज्य सहकारी समिति निर्धारित समय अवधि के भीतर केंद्र सरकार द्वारा बनाए गए सहकारी शिक्षा कोष (सी. ई. एफ.) में प्रत्येक वित्तीय वर्ष में अपने शुद्ध लाभ के एक प्रतिशत (1 प्रतिशत) के बराबर राशि का योगदान करेगी।

2. यह ध्यान दिया जा सकता है कि उपरोक्त प्रावधान सहकारी शिक्षा, प्रशिक्षण, क्षमता निर्माण और सहकारी क्षेत्र में व्यावसायिक विकास को मजबूत करने और संघों सहित सभी बहु-राज्य सहकारी समितियों द्वारा इसका नियमित अनुपालन करने के उद्देश्य से पेश किया गया है।

3. सी. आर. सी. एस. पोर्टल पर आपकी सोसायटी द्वारा इलेक्ट्रॉनिक रूप से दाखिल की गई वर्ष 2024-25 की वार्षिक रिपोर्ट की जांच के दौरान, यह देखा गया है कि आपकी सोसाइटी ने वर्ष 2024-25 के दौरान सी. ई. एफ. फंड में लाभ का 1 प्रतिशत नहीं भेजा, भले ही आपने उस वर्ष के दौरान लाभ अर्जित किया हो। एम. एस. सी. एस. (संशोधन) अधिनियम 2023 की धारा 63 आई (बी) के तहत सभी लाभ कमाने वाली समितियों द्वारा इस कोष में योगदान करना अनिवार्य है। इसलिए, आपको यहां सी. ई. एफ. (वर्ष 2024-25 के लिए सहकारी शिक्षा कोष में योगदान) में तुरंत योगदान करने का निर्देश/अनुरोध किया जाता है।


Sir,

I am directed to refer to the provisions of the Multi- State Co-Operative Societies Act, 2002, as amended by the Multi-State Co-operative Societies (Amendment) Act, 2023, which, inter alia, mandate that "every multi-state co-operative society shall contribute an amount equivalent to one per cent (1%) of its net profits each financial year to the Co-operative Education Fund (CEF) maintained by the Central Government, within the prescribed time period"

2. It may be noted that the aforesaid provision has been introduced with the objective of strengthening cooperative education, training, capacity building and professional development in the cooperative sector, and its regular compliance by all multi-state co-operative societies, including federations.

3. During examination of the annual reports for the year 2024-25 electronically filed by your society on the CRCS portal, it is noticed that your society did not remit 1 percent of profit to CEF fund during the year 2024-25 despite you have earned profit during that year. It is mandatory to contribute to this fund by all profit-making societies U/S 63 1 (b) of the MSCS (Amendment) Act 2023. So, you are here by directed/requested to contribute to CEF (Co-operative Education Fund) for year 2024-25 immediately, without fail.
