Sub.: Seeking directions on the representations received against exclusion of name from Final Electoral Roll in respect of Election of the National Cooperative Union of India (NCUI)-reg.

Sir,

I am directed to refer to your letter No. DM(S)/RO/NCUI/2026/02 dated 27.06.2026 regarding receipt of representations from certain members of the NCUI subsequent to publication of the **“Final list of members/delegates (group-wise and constituency-wise) eligible to vote”** on 25.06.2026. The applicants have contended that their names were included in the provisional electoral roll which was published on 16.06.2026 by the RO who were subsequently omitted from the final electoral rolls without assigning any reason and without affording opportunity of hearing. In representation, the petitioners have requested restoration of their names in final electoral roll and seeking an opportunity of hearing, acceptance of fresh Board resolution and extension of time for final nominations.

2. The request of the RO and the enclosed representations have been considered in the meeting of the Cooperative Election Authority (CEA) held on 27.06.2026 and keeping in view the principle of natural justice, free and fair conduct of elections and for providing level playing field, the following has been decided:

- (i) RO is requested to consider all Fresh Resolution and representations which have been received or will be received up to 30.06.2026 and pass an order for inclusion or exclusion of members from the **“Final List of members/delegates (Group wise & constituency wise) eligible to vote”** published on 25.06.2026. In case of rejection of request/claim, hearing may be provided through video



conference or in person, as RO may decide. All such orders passed may be hosted on the website and notice board of NCUI.

(ii) Fresh resolution, if submitted as per Rule 19H (5), Rule 19H (6) & Rule 19H (7), the same may be accepted by RO up to 30.06.2026.

(ii) In case of inclusion of names in the “**Final List of members/delegates (Group wise & constituency wise) eligible to vote**” then, a supplementary list be published under the heading “**Supplementary list to the Final List of members/delegates (Group wise & constituency wise) eligible to vote**” and published on the website and notice board of NCUI on 1<sup>st</sup> July, 2026.

3. In view of the fact that now RO will have to consider additional representations received till 30<sup>th</sup> of June, 2026 and taking into consideration that the date of filing of nominations has already commenced from today i.e. 27.06.2026, the Authority has agreed to RO’s proposal to revise election schedule as follows:

RO is requested to ensure that wide publicity is given for change of election schedule, opportunity of giving time to submit representation in respect of cases mentioned above, displaying of revised program on the website of the Society, notice board of the Society and by sending email to members.
