I am directed to refer to your recommendations received through above mentioned reference regarding election of 11 (Eleven) Board of Directors of "Fingrowth Cooperative Bank, Jaipur, Rajasthan" in the Format 19 M and to convey the approval of Cooperative Election Authority under Rule 19 M of MSCS Act for election of 10 (Ten) Directors (Gen- 8 and Women-2) indicated at Sl. Nos from 2 to 11 in Form 19 M submitted by the RO vide letter dated 23.06.2026. Name and address of the approved Board of Members have been indicated by RO in Format 19 M (Under Rule 19 M)

2. **You are requested to declare the result of the election excluding, the result of one director from Jaipur constituency in respect of Shri Abhimanyu Kumar Golcha (Representative of Golcha Minerals Pvt. Ltd.) indicated at Sl No. 1 in the Form.** An appropriated decision will be taken separately by the Authority on receipt of clarification of RO.

3. Returning Officer is also requested to direct CEO of "Fingrowth Cooperative Bank, Jaipur, Rajasthan" that approved result of the election of Board Members may be displayed in conspicuous manner on the website of the society.

4. For conduct of election of Office Bearers, it is requested that Rule 19 N i.e. "Election of Office Bearers by secret ballot" be kept in view of which inter-alia provide that the meeting to elect office bearers shall not be conducted unless majority of newly elected members of the board are present.



5. Returning Officer is requested to refer to Section 44 of the Multi State Cooperative Societies Act, 2002, to ensure that member of the Board of Director recommended for the position of Chairperson or President has not been the Office of Chairperson or President during two consecutive terms, whether full or part. While filling nominations for Office Bearers, the following information may be obtained:

6. Further such meeting shall be presided over by Returning Officer.

7. **Preparation of Account of election expenses and lodging of the same with RO:** From conjoint reading of the Rule 19 U & Rule 19 W, it is clear that all candidates shall prepare account of all expenditure in connection with the election. Account be prepared as per particulars given in Rule 19 W. No limit for election expenditure for the candidate has been fixed by Cooperative Election Authority till now. The account of expenditure must be lodged by the candidates with the Returning Officer within 30 days otherwise it attracts disqualification for failure to lodge account of election expenses. Such compiled return may be submitted to the Cooperative Election Authority (CEA).

8. Returning Officer is requested to ensure that society has deposited remuneration for Returning Officer/Assistant Returning Officer/Polling Officer in Cooperative Election Authority's Account.
