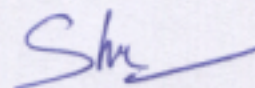
(Under Section 86 of the Multi State Cooperative Societies Act, 2002)

Whereas, Southern Green Farming and Marketing Multi-State Cooperative Society Ltd., 65/1508, First Floor, Thanveer Complex, Near English Church, West Nadakkav, Kozhikode, Kerala - 673011 (Regn. No.: MSCS/CR/286/2008) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules framed thereunder (hereinafter referred as Act).

2. A number of complaints related to non-repayment of deposits of members were received against the Society in the Office. These Complaints were forwarded to the Society vide letters dated 22.07.2025 and 20.02.2026 for seeking comments in the matter. However, no response was received from the society. Also, the Cooperative Ombudsman's order dated 16.07.2025 mentions that "some of the notices and reminders have been returned undelivered with remarks, 'door lock' and 'closed down, RTS,' on the envelopes. Mails sent to the society have also bounced back". Further, the Society has failed to file its mandatory annual returns u/s 120 of the MSCS Act, 2002 to the Central Registrar for the financial year 2024-2025.

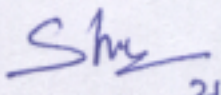
3. In respect of 13 complaints received against the society regarding non-repayment of deposits of members, the Cooperative Ombudsman vide order dated 16.07.2025, directed the Society to pay the amount of deposits due & claimed by the complainants against their respective deposits along with up-to-date interest thereon within 15 days from the date of issue of the Order. Further, in that order, it was also mentioned that "some of the complainants have also enclosed minutes of the meeting held with the management of the society on 25th March, 2025, wherein the Chairman of the society committed to making the payments in a time bound manner. However, the commitments were not fulfilled by the society".

4. Further, the Cooperative Ombudsman vide communication dated 17.07.2025 has reported to the Central Registrar that Southern Green Farming and Marketing Multi-State Cooperative Society Ltd. has not complied to the Order of Cooperative Ombudsman. Thereafter, the Central Registrar fixed the hearings of the society through Video Conference on 16.10.2025, 27.11.2025, and 24.02.2026, but no authorized representative of the Society appeared in any of these hearings.



5. Additionally, vide letter dated 04.01.2026, the Deputy Police Superintendent, Kottayam, Kerala stated that it is alleged that the Society accepted deposits from the general public and thereafter cheated the investors by closing down the establishment without refunding the deposited amounts.

6. Therefore, after careful consideration of the facts, it appears to the undersigned that the Society is not functioning in accordance with the provisions of the MSCS Act, 2002 and Rules framed thereunder, approved bye-laws, and Cooperative Principles and is also not found at its registered address. Therefore, the undersigned is of the opinion that winding up process under the provisions of the MSCS Act, 2002 and Rules framed thereunder be initiated against the society. If society or any person, has any objection thereto, the same may be brought to the notice of this authority within 15 days from the date of uploading of this Notice on the official website i.e., crcs.gov.in failing which it will be presumed that the Society or any other person has nothing to say and further action would be initiated for winding up of the Society under the provisions of the MSCS Act, 2002 and rules made thereunder.
