**INTERIM ORDER**

An appeal dated 27.10.2025 has been filed by Chairman, Latur Multi State Cooperative Credit Society Ltd., Latur, Maharashtra (hereinafter referred to as 'Appellant Society') under Section 85A(3) of the Multi-State Cooperative Societies Act, 2002 read with Rule 30J of the Multi-State Cooperative Societies Rules, 2002 against the order dated 03.10.2025 passed by the Cooperative Ombudsman.

2. The Co-operative Ombudsman, vide the aforesaid order, had issued directions to the appellant Society to pay the amount of deposit due and claimed by Rajlaxmi Multi State Credit Cooperative Society Ltd., Yavatmal, Maharashtra (hereinafter referred to as 'Respondent Society') against their fixed deposit along with up-to-date interest thereon as applicable within 30 days from the date of issue of this order. Aggrieved by the said directions, the appellant Society has preferred the present appeal.

3. The appeal was taken up for hearing on 21.07.2026 before this Authority. During the course of hearing, the Appellant made detailed oral submissions in support of the appeal and reiterated that the balance amount of the fixed deposit was withheld pursuant to contractual commitments and mutual arrangements entered between the parties. The Respondent contested the said submissions.

4. Since the Appellant has relied upon certain facts and contractual arrangements in support of the appeal, it is considered appropriate that the same be placed on record by way of written submissions duly supported by documentary evidence so as to enable proper adjudication of the appeal.

5. Accordingly, the Appellant, Latur Multi State Cooperative Credit Society Ltd., Latur, Maharashtra, is directed to file its written submissions, duly supported by all documents and evidence on which it seeks to rely, within fifteen (15) days from the date of this Order. A copy of the written submissions along with all supporting documents shall simultaneously be served upon the

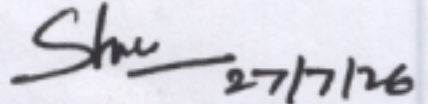
Respondent, Rajlaxmi Multi State Credit Cooperative Society Ltd., Yavatmal, Maharashtra.

6. The Respondent may file its written response/reply to the Appellant's submissions, along with supporting documents, if any, within fifteen (15) days from the date of receipt of the Appellant's written submissions, after serving an advance copy thereof upon the Appellant.

7. Upon completion of the aforesaid pleadings, the matter shall be listed for final hearing, for which a separate notice indicating the date and time of hearing shall be issued to both parties.
