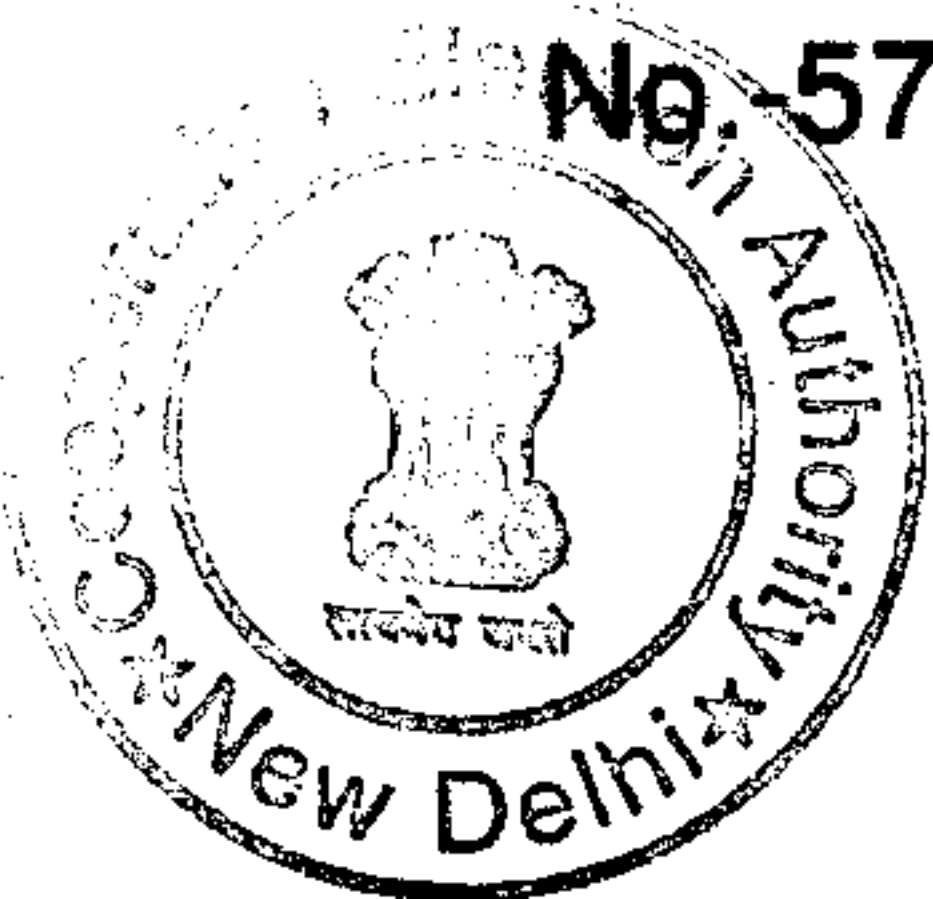

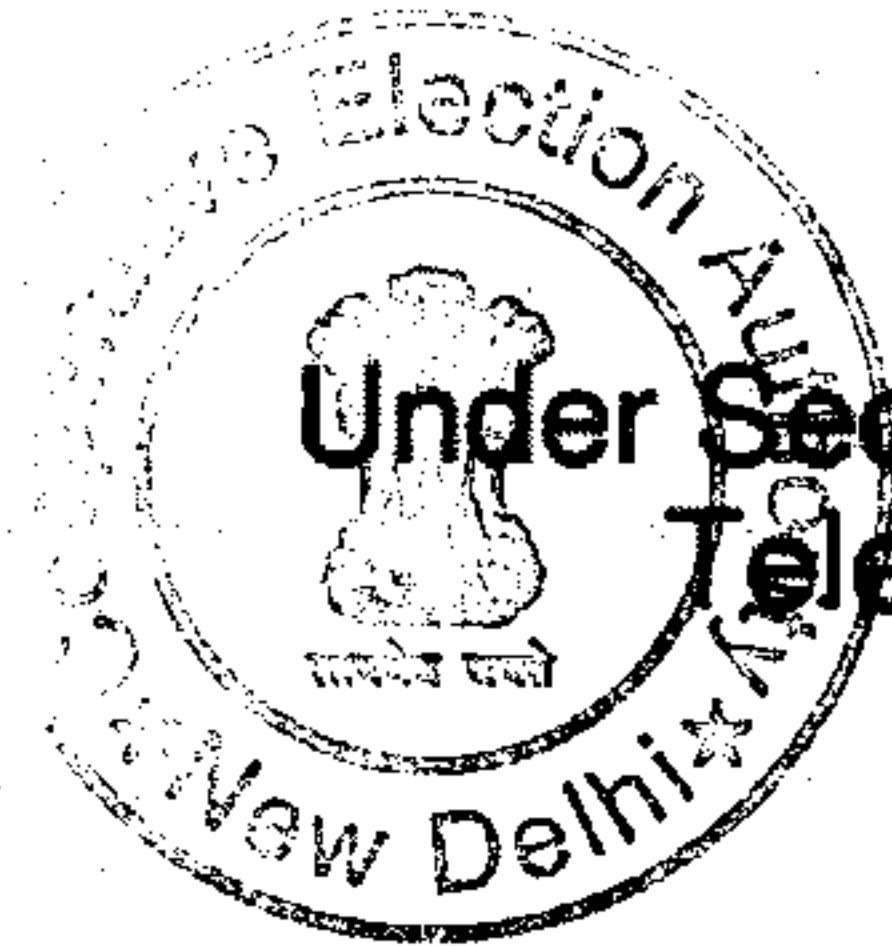
5. Further such meeting shall be presided over by Returning Officer.
