I am directed to refer to the Hon'ble High Court of Judicature at Bombay (Circuit Bench at Kolhapur)'s Judgement dated 25.06.2026 and to say that the Order in the Writ Petition No.2438 of 2025 is extracted below, the **Hon'ble High Court decided and order issues as under:**

“1.Rule is made absolute by quashing judgement and order dated 14.02.2025 passed by respondent No.1-Returning Officer and upholding the nominations of the petitioners.

2. The Respondent Authorities shall be at Liberty to proceed with fresh election process or to continue the process from the stage of the scrutiny of the nomination papers.

3. The Respondent nos.4, 6 to 87, whose nominations are rejected, shall not entitled to receive the benefit of order passed today unless a court-fees is paid and proof thereof is submitted to the respondent-Authorities.

4. There shall be no order as to costs.



3. Effective steps may be taken for publicity about the poll date, in case of poll through newspaper, electronic medium, SMS, email so as to ensure participation of members can be assured.

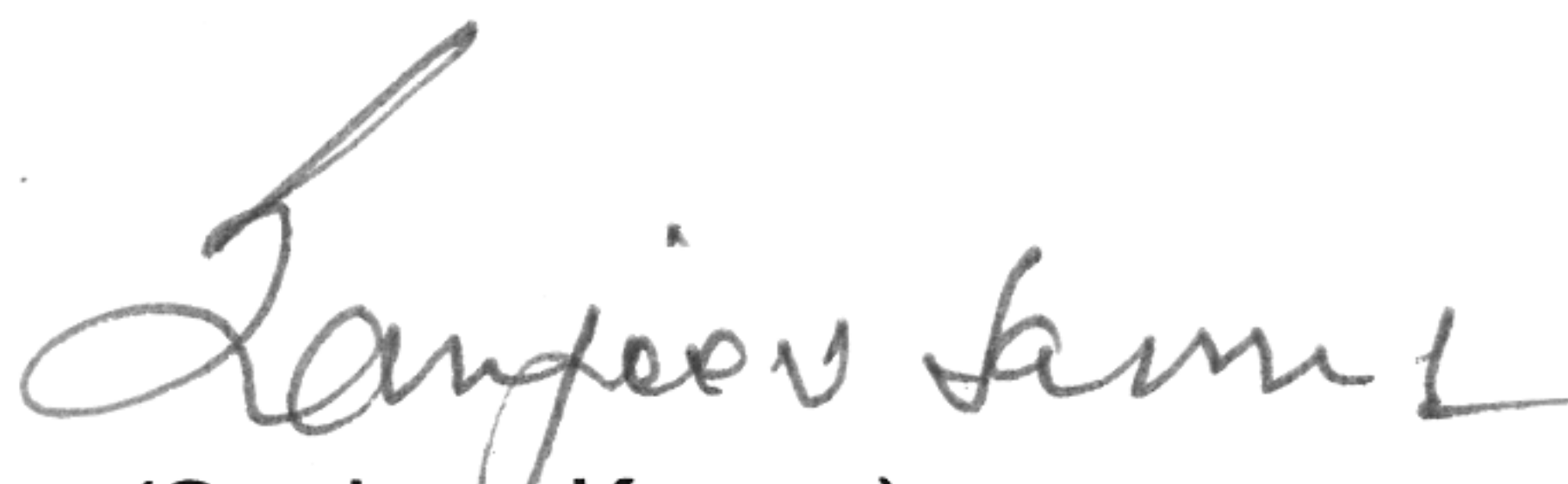

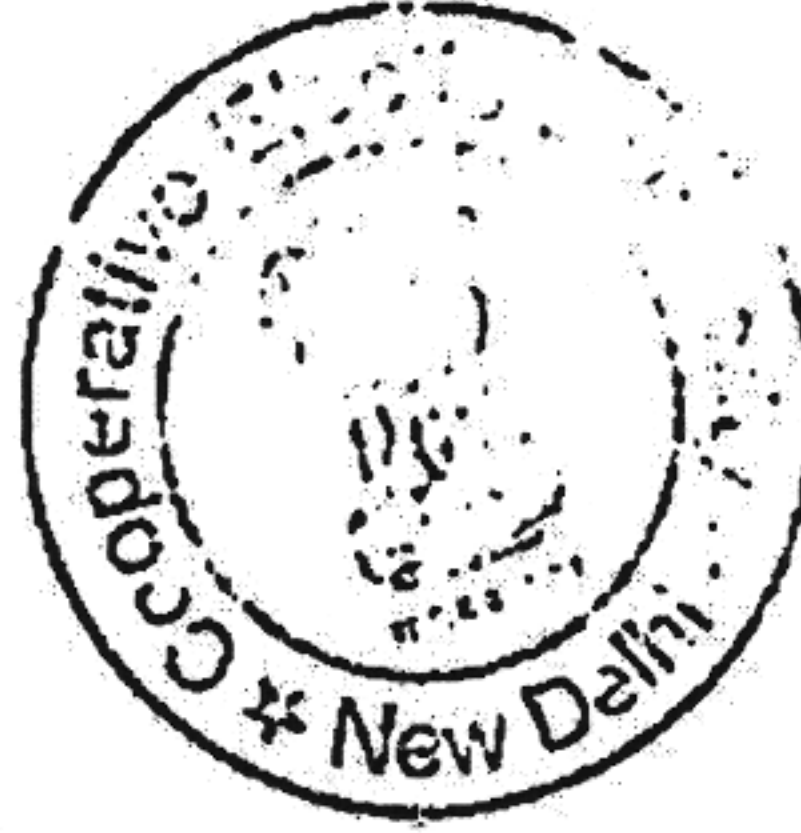

2. Members will cast vote as per section 31 and 32 of Multi-State Cooperative Society Act.

Further, in view of Rule 19(H)(2) of the MSCS Rule 2002 as amended in 2023 with MSCS Rule as 2023, the Election Program for conducting election of the aforementioned Society is enclosed for further necessary action. RO is requested to ensure the election is conducted as per the MSCS Act, 2002 and Rules framed there under.
4. After conduct of Elections of Board of Directors, the RO is mandated to submit the requisite details in Format 19 M (for members of the Board of Directors) under Rule 19 M for seeking prior approval of the Cooperative Election Authority
5. After conduct of Elections of Office Bearer (One Chairman & One Vice-Chairman), the RO shall submit the requisite details in Format 19 N for seeking **prior approval** of CEA before declaration of results.
6. Returning Officer shall ensure that the Society prominently displays the **List of Eligible Voters, Election Program and Final List of the Contesting Candidates**, and other related important documents on the website of the society for enabling free, fair and transparent elections.

8. Instructions for filling-up of the Format-M and N have been appended below the Format 'M' and 'N', the same should be scrupulously followed by the Returning Officer.
9. Further, It is also requested to provide the requisite details about basic pay of RO and ARO and other polling officers in the enclosed Performa to claim remuneration from the society in connection with discharge of duties for conduct of election as RO/ARO/Polling personnel etc.

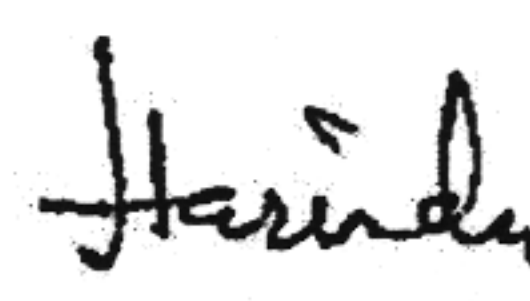
