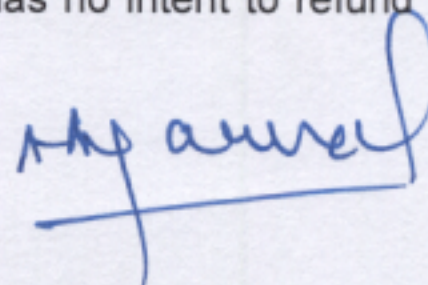

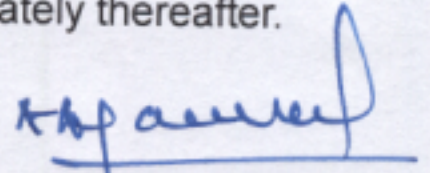
ORDER

1. Paton Constructions Private Ltd., in their complaint filed through their Authorized Representative Shri Darshan Pravin Satra, have stated that they had invested Rs.25.00 lakh for a period of one year in fixed deposit with the respondent society on 18th November, 2024. Upon maturity of deposit, they through various applications, latest via email dated 27th January, 2026 requested the society to refund their deposit. The society neither acceded to refunded the deposit nor did it give any reply.
2. Office of the Cooperative Ombudsman issued notices dated 06th & 27nd May, 2026 to the respondent society seeking its response to the complaint. No response was received to any of the notices and emails.
3. On perusal of the facts and available record, following aspects emerge:
 - a) Complainant had requested the respondent society to refund their deposit. The society neither made any refund nor did it reply to the request of the complainant.
 - b) Notices issued by this office to the society went unanswered and returned undelivered with remarks 'left address.' No response was received to any of the emails sent by this office.
 - c) Evidently the society is incommunicado and has no intent to refund the deposits



4. After due consideration of the representations made, documents submitted and the relevant provisions of law, the matter is hereby disposed off with following directions:

- i. Shri Sant Dnyaneshwar Multi State Cooperative Credit Society Ltd. is hereby directed, in their own interest, to pay the amount of deposit due & claimed by the complainant against their deposit along with up-to-date interest thereon as applicable within 30 days from the date of issue of this Order.
- ii. Compliance report to be submitted to this office immediately thereafter.
