ORDER

(Under Section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas, Senapati Bapat Multi State Cooperative Credit Society Ltd., Parner, Taluka Parner, District Ahilyanagar, Maharashtra (Registration No. MSCS/CR/345/2010) is registered under the provisions of the Multi-State Co-operative Societies Act, 2002 (hereinafter referred to as the "Act") and the Rules made thereunder;

2. As per the periodic report submitted by the Office of Cooperative Ombudsman, an Order dated 04.06.2025 was issued by the Cooperative Ombudsman directing the Society to pay the amount due and claimed by the complainant against his deposit. However, the Society neither complied with the said Order nor preferred any appeal before the Central Registrar of Cooperative Societies. Further, hearings were held through Video Conference by Central Registrar of Cooperative Societies on 16.10.2025, 27.11.2025 and 24.02.2026, but no authorized representative of the Society appeared on any of the above dates.
3. As per the records of the CRCS Office Portal, the Society has not submitted its mandatory annual returns for the financial year 2024-25 under Section 120 of the Multi-State Co-operative Societies Act, 2002, thereby indicating continued non-compliance with the statutory requirements.
4. The Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra, vide letter dated 30.04.2026, has reported that the tenure of the members of Board of Directors of the Society expired in December 2025 and that the depositors of the Society had filed FIR No. 463/2025 dated 11.06.2025 against the Directors at Police Station, Parner, District Ahilyanagar.
5. Therefore, a Notice dated 02.06.2026 was issued by this Office inviting objections to the proposed winding up of the Society and providing an opportunity to the Society to submit its objections within 15 days from the date of uploading of the Notice on the official website. No objection was received from the Society within the stipulated period.
6. Whereas, vide letter dated 16.06.2026, the Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra was requested to provide name/designation of an officer who could be considered for appointment as Liquidator of the Society. The Commissioner for Cooperation

- and Registrar, Cooperative Societies, Govt. of Maharashtra, vide letter dated 07.08.2026, has recommended Assistant Registrar, Cooperative Societies, Parner, District Ahilyanagar for appointment as Liquidator of the Society.
7. Now, therefore, after careful consideration of the facts, I, Shiv Pal Singh, Central Registrar of Cooperative Societies, in exercise of the powers conferred under Section 86 of the Multi-State Co-operative Societies Act, 2002, hereby direct the winding up of the above Society and appoint the **Assistant Registrar, Cooperative Societies, Parner, District Ahilyanagar, Maharashtra** as Liquidator under Section 89(1) of the Act to wind up the affairs of the Society in accordance with the provisions of the Multi-State Co-operative Societies Act, 2002 and the Rules made thereunder.
8. The Liquidator shall take into custody and control all the property, effects, actionable claims, books, records and other documents of the Society and shall take all necessary steps for completion of the liquidation proceedings in accordance with the provisions of the Act and Rules made thereunder.
9. The Liquidator shall endeavour to finalize the liquidation proceedings within a period of three months from the date of this Order and shall submit a status report to this Office indicating the progress made in the liquidation proceedings.
