Subject: - Conduct of elections of Office Bearers of Farmers Consumers Society Limited – reg.

Sir,

I am directed to refer to an email dated 16.07.2026 vide which Form 19N has been forwarded for approval under Rule 19N to declare the results of Office Bearer of the Society namely Farmers Consumer Cooperative Society Ltd.

2. While examining Form 19N, it was observed that Col.4 regarding date and time of Board meeting etc., of the Form was left blank. In this regard, the RO office was contacted telephonically to get the Form 19N duly filled up completely.

3. The Form 19N received on whats app contains the information in col.4 of the form 19N which states that ***"meeting not required as only 02 nominations have been received for the election of 02 posts of Office Bearers."***

4. In this regard, Rule 19N(1), which is read as under, may be referred:

"19N. Election of office bearers by secret ballot

(1) As soon as the members of the board have been elected, the Returning Officer shall, notwithstanding anything contained in the bye-laws of the multi-State co-operative society, convene a meeting of the newly constituted board for the purpose of election of the President or Chairperson, Vice-President or Vice-Chairperson or other elected office bearers of the society, by whatever name they are called, in accordance with the directions of the Authority and such meeting shall not be conducted unless majority of the newly elected members of the board are present, as per bye-laws of the society."

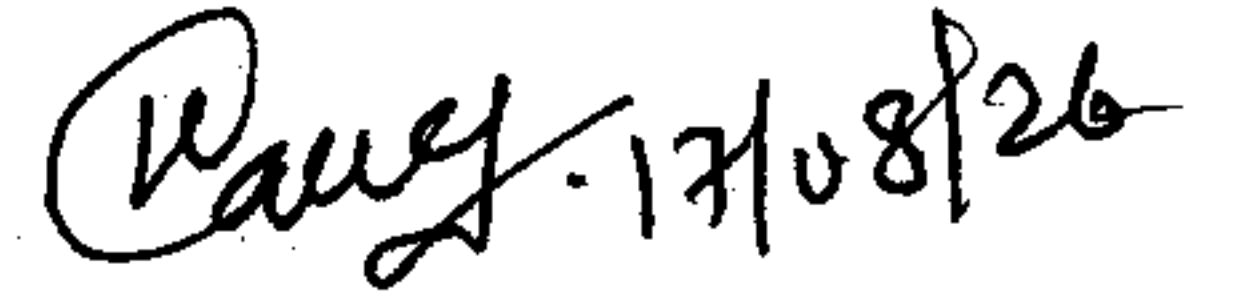
2. In view of the Rule position stated above, convening of meeting is must even if there are two candidates, i.e., one for Chairperson and other for Vice-Chairperson. Therefore, you are requested to convene the meeting of the newly constituted Board as per the Schedule mentioned below for election of Office Bearers of the Society:

1	Meeting of Newly Constituted Board & Publication of List for valid Nominations, Polling (if required)	31 st August, 2026 (Monday)	3.00 PM Onwards
2	Sending of recommendation to CEA for seeking prior approval	31 st August, 2026 (Monday) By evening	
3	Declaration of Result of Election of Office Bearers	After approval of Cooperative Election Authority, New Delhi on Format 19N	

3. It may be noted that the nominations already received by the Returning Officer shall remain the same and stand frozen.
