UoI Thru. Addl. Secy. Central Registrar of Cooperative Societies and Ors.* and Writ (C) No. 2050-2023 titled *Dhirendra Kumar Shukla & Others Vs. Union of India Thru. Addl. Secy. 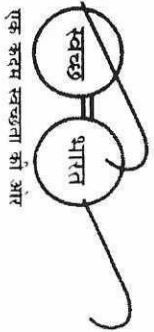
