TO WHOM SO EVER IT MAY CONCERN

(Under Section 86 of The Multi-State Cooperative Societies Act, 2002)

Whereas, Moneyedge Multi-State Multipurpose Cooperative Society Ltd. (formerly known as Jivan Multi-State Multipurpose Cooperative Society Ltd.), Registration No. MSCS/CR/838/2013, (hereinafter referred as Society) having its present registered office at LG 34, Avior Corporate Park, LBS Marg, Mulund West, Mumbai, Maharashtra-400080, is registered under the provisions of the Multi-State Co-operative Societies Act, 2002 and the Rules framed thereunder (hereinafter referred as Act);

2. The Cooperative Ombudsman, in the matter of Shri Dilip Shamarao Shikhare Vs. Jivan Multi State Multipurpose Cooperative Society Ltd., vide Order dated 17.06.2025, directed the society to pay the amount due and claimed by the complainant against his deposits, along with up-to-date interest, within 15 days from the date of the Order and to submit a compliance report to the Office of the Cooperative Ombudsman. The order records that the society had not responded to the proceedings and had not attended the hearing.

3. As per the periodic report received from the Office of the Cooperative Ombudsman, the society did not comply with the aforesaid Order dated 17.06.2025, nor did it file an appeal before the Central Registrar of Cooperative Societies. Further, hearings through Video Conference were convened on 16.10.2025, 27.11.2025 and 24.02.2026, but no authorised representative of the society appeared on any of the said dates.

4. As per the records available on the CRCS Portal, the society has not submitted its mandatory annual returns under Section 120 of the Multi-State Co-operative Societies Act, 2002 to this Office.

5. Now, therefore, in exercise of the powers conferred under Section 86 of the Multi-State Co-operative Societies Act, 2002, and in view of the facts and circumstances stated above, it is proposed to initiate the winding-up process of **Moneyedge Multi-State Multipurpose Cooperative Society Ltd.** The society is hereby called upon to submit its representation/objection, if any, against the proposed winding-up of the society within 15 days from the date of

uploading/receipt of this Notice on the official website/CRCS Portal i.e., crcs.gov.in. In case no representation/objection is received within the stipulated period, it will be presumed that the society has nothing to say in the matter, and further action for winding up of the society shall be initiated in accordance with the provisions of the Multi-State Co-operative Societies Act, 2002 and the Rules made thereunder.
