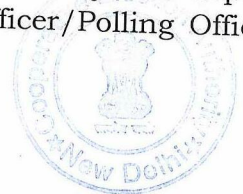

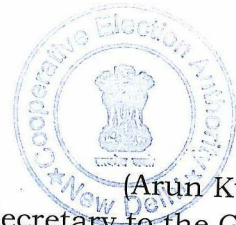

Pursuant to the above subject and reference, it is hereby submitted that,

With reference to above cited subject, Multistate Co-operative society Shri Mahakali Sahakari Sakhar Karkhana Ltd., Rajarambapunagar, Kavathe Mahankal Tal- Kavathe Mahankal, Dist- Sangli, Maharashtra has been registered under Multi-State Co-operative Societies Act. To conduct the election of 17 Board members and 2 office bearers of this society, District Collector and District Magistrate Sangli is appointed as Returning Officer.

After the stage of withdrawal of nomination forms, the election was held on 06/09/2026 & the counting of votes are conducted on 09/09/2026 and the result of the election was submitted to your good office for your kind acceptance. Approval for the said result has been received from your good office vide Reference No. 2 cited above.

After approval of 19M and as per the approved election programme, the election process for office bearers, including submission of nomination forms, scrutiny, withdrawal of nominations, and publication of the final list of contesting candidates on the notice boards of the Returning Officer's office and the factory site on 15/09/2026, was completed.

At the time of submission of nomination forms, total 3 nominations were received for the post of Chairman and 1 nomination was received for the post of Vice-Chairman. After scrutiny, all 4 nominations were found valid. During the withdrawal period, 2 nominations for the post of Chairman were withdrawn. After withdrawal, 1 final contesting candidate remained for the post of Chairman and 1 final contesting candidate remained for the post of Vice-Chairman.

Subsequently, a meeting of the newly elected candidates was held on 16/09/2026, and the result of the office-bearer election (19N) was submitted to your good office for kind acceptance.

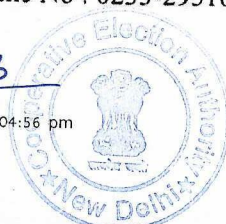
